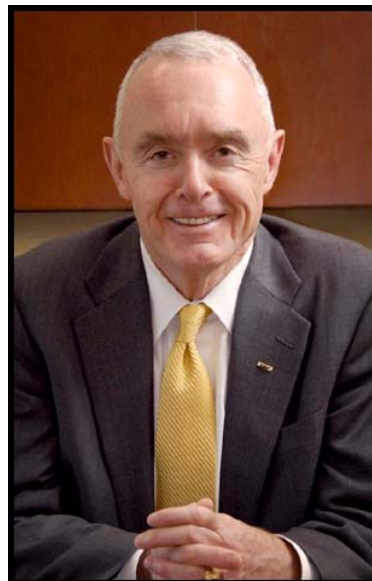

Challenges Facing the Obama Administration

General McCaffrey will discuss the challenges facing the new administration and how policy is made in Washington.

At retirement from active duty, after 32 years of military service, General Barry McCaffrey was the most highly decorated four-star general in the U.S. Army. Having serviced for five years as the nation's Cabinet Officer in charge of U.S. Drug Policy, General McCaffrey now serves as a national security and terrorism analyst for NBC News, is an Adjunct Professor of International Affairs at the U.S. Military Academy at West Point, and serves on the Board of Directors of HNTB Companies, an employee-owned organization of infrastructure firms with 63 offices nationwide known and respected for their work in transportation, tolls, bridges, aviation, rail, architecture and urban design, and planning.
