With headlines screaming the news of auto industry bankruptcies and government bailout programs, it's good to know that there is also some positive news about the future of the Automobile industry. The Fisker Karma Sunset PHEV hardtop convertible coupe has been named 2009 Production Preview Concept of the Year, part of the North American Concept Vehicle of the Year Awards, which recognizes those **vehicles most likely to shape the future of the automobile industry.** Irvine-based Fisker Automotive, a 'green' American premium sports car company with a mission to create a range of beautiful environmentally friendly cars that make environmental sense without compromise, was named one of the most successful startups of 2008 by *Business Week*. The production version of its sporty luxury plug-in hybrid *Fisker Karma*, which has solar panels on the roof and is designed for top speed of 125 mph, debuted in January and will have a starting price of \$87,900 when it rolls off the assembly line in October. There are currently 31 dealers across the U.S. set to sell the *Karma*, including one in Irvine. Henrik Fisker, the company's founder and CEO, will share his views on the success of the Irvine-based company, as well as his perspective on the future of the automotive industry.
